The student-athlete must be picked up at the contest by her parent; the parent must speak with the coach prior to leaving with his/her child.</li> <li>The parents submit a completed Transportation Waiver Form to the Athletic Director 24 hours prior to the contest, allowing the student to travel home with the parents of another athlete. The parents of both athletes must complete the form. The parents of the other athlete (the driver) must speak with the coach prior to leaving with the student-athlete.</li> <li>The parents submit a completed Transportation Waiver Form to the Athletic Director 24 hours prior to the contest, allowing the student-athlete to drive to and from a contest and/or offsite practice.</li> <li>The parents submit a completed Transportation Waiver Form to the Athletic Director 24 hours prior to the contest, allowing the student-athlete to drive to and from a contest and/or offsite practice and to transport another student-athlete. The parents of the student-athlete passenger must also complete a Transportation Waiver Form giving permission for their daughter to be driven by another student-athlete.</li> <li>Lauralton Hall provides transportation to practices which are held in the afternoon of school days and conducted off campus. Students who wish may inform their coach and then take the team bus to practice and to arrange their own transportation home from practice.</li> </ul>
