ATHLETIC TRAVEL WAIVER

Lauralton Hall provides transportation to and from away contests. All student-athletes are expected to travel to and from the competition on the team bus. Parents who opt not to utilize this transportation are assuming all risk and cannot hold the school liable for any issues that may result. Student-athletes are not allowed to drive to and from away contests. Exception is made to this policy only when:

- The parents submit a Travel Waiver form to the Athletic Director 24 hours prior to the contest, allowing the student to travel home with her parents. The student-athlete must be picked up at the contest by her parent; the parent must speak to the coach prior to leaving with his/her child.
- The parents submit a completed Travel Waiver form to the Athletic Director 24 hours prior to the contest, allowing the student to travel home with parents of another athlete, The parents of **both athletes** must complete the form. The parents of the other athlete (the driver) must speak with the coach prior to leaving with the student-athlete.
- The parents submit a completed Travel Waiver form to the Athletic Director 24 hours prior to the contest, allowing the student-athlete to drive to and from a contest and/or offsite practice.
- The parents submit a completed Travel Waiver form to the Athletic Director 24 hours prior to the contest, allowing the student-athlete to drive to and from a contest and/or offsite practice and to drive another student-athlete. The parents of the student-athlete passenger must also complete a Travel Waiver form giving permission for their daughter to be driven by another student-athlete.
- Lauralton Hall provides transportation to practices which are held in the afternoon of school days and conducted off campus. Students who wish may inform their coach and then take the team bus to practice and arrange their own transportation home from practice.

By signing this form you will release the Academy of Our Lady of Mercy, Lauralton Hall and its agents from any claim, liability, damage, or loss of any type whatsoever which may arise in connection with the choice you have made. In doing so, you acknowledge your authority to sign this release.

In order for a release to be granted for a student-athlete to ride with another student-athlete or a student-athletes family, both families must agree with the riding situation. Therefore, both families must have a waiver on file. **PLEASE CHOOSE ONE OF THE OPTIONS BELOW:**
